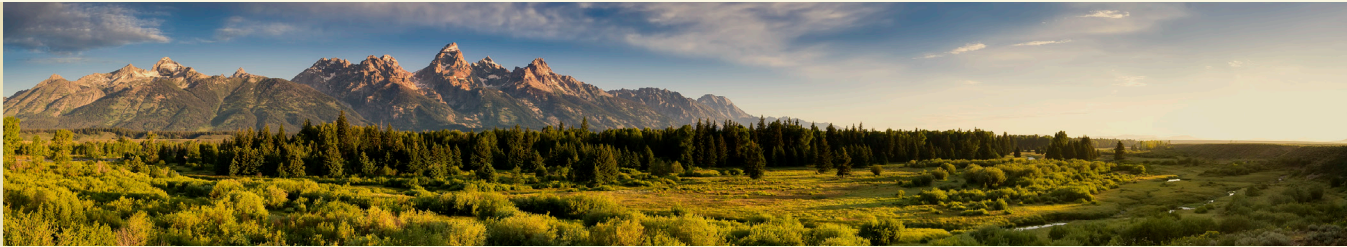

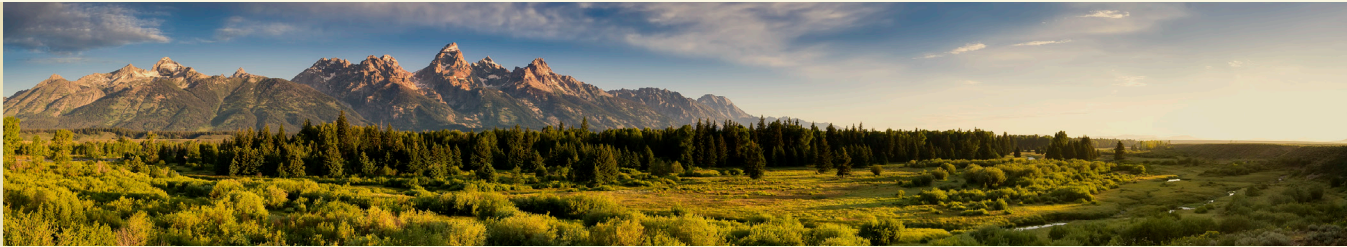

About Wyoming

Wyoming is a top trust situs due to its favorable tax environment, strong asset protection and privacy laws. It is an efficient, flexible and cost effective jurisdiction in which to domicile trusts.

DIRECTED TRUSTS

The Wyoming directed trustee statute provides Wyoming situs and allows for the separation of fiduciary responsibilities.

INVESTMENTS

Under Wyoming statute, a settlor or beneficiary may designate a trust protector or trust advisor to direct the fiduciary's investment decisions. This separation of duties allows the family to use its preferred advisors to invest assets according to wealth preservation goals. Willow Street Trust Company does not provide investment advisory services.

DISTRIBUTIONS

The directed trustee model allows for a trust protector, trust advisor or distribution committee to direct distributions. Often, there is a requirement that a disinterested third party perform the distributive function. Willow Street Trust Company can serve in this role if desired.

ADMINISTRATION

Willow Street Trust Company carries out the administrative duties of a trustee, which include compliance, back office services and communication with beneficiaries.

PRIVATE FAMILY TRUST COMPANIES (PFTC)

Wyoming is one of only a few states that permit both Regulated and Unregulated Private Family Trust Companies (PFTC) to act as corporate trustee for a single family's trusts. The PFTC structure is a strong governance tool and provides the family with control, flexibility and privacy.

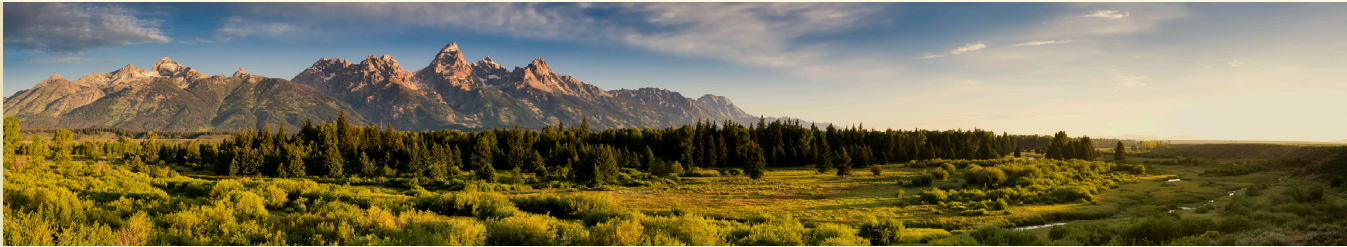
REGULATED

In 2015, Wyoming enacted the Family Trust Company Charter Act to permit regulated PFTCs. Essentially, this provides families with the privacy and control of a PFTC, with the benefit of oversight from the Wyoming Banking commission. This works well for families not meeting the SEC's Single Family Office exemption.

UNREGULATED

An unregulated PFTC is used when a family places a high value on privacy, has stringent internal controls and meets the SEC's Family Office exemption definition. Compliance and auditing requirements are established by the Directors of the PFTC, rather than by the state.

The Willow Street Trust Company creates a strong nexus to Wyoming through exceptional administration, documentation and communication and has been providing full back office services and compliance functions for Wyoming PFTCs, trusts and family offices since 2005.
